THIS SHOW WILL BE CONDUCTED UNDER THE ARABIAN HORSE SOCIETY RULE BOOK AND THE FOLLOWING SA ARABS Inc RULES

1. The lodging of any entry shall bind the exhibitor to the conditions of entry and the regulations set out here in and the signature of any exhibitor on the entry form shall constitute acceptance of these conditions
2. SA ARABS Inc Committee shall have the power without giving reason to:
  - i. Alter the time of the scheduled event or class starting time
  - ii. Remove any exhibitor from the showground for displaying abuse towards their horse.
  - iii. Combine any classes
3. Rings will not be held up for competitors who have clashing classes. However every endeavour will be made to ensure that clashes do not occur.
4. Championship Classes and Senior Rider Championship Classes will be awarded Champion, Reserve Champion and Top 5 Sashes and awards. Top 5 sashes will be allocated according to the number of horses entered in the show catalogue. (1-2 horses - Champion and Reserve Champion; 3 horses – Champion & Reserve Champion, 1 top five sash; 4 horses - Champion, Reserve Champion, 2 top five sashes and 5+ horses Champion & Reserve Champion and 3 top five sashes)
5. Stallions and colts will not be permitted to be handled, ridden, or driven by any person under 18yrs whilst on the show grounds.
6. All exhibits, including foals, must be registered with the AHSA and the registration number must be quoted on the entry form. A photo copy of the registration certificate MUST accompany entries. Pending registrations are not acceptable. Ages of the horses/ponies are referenced to the 1st August convention.
7. All exhibits must be able to be identified by their brands or microchip and/or markings in accordance with the Certification of Registration issued by the Society. Change of coat colour or adding white markings is prohibited and may result in disqualification
8. SA ARABS Inc shall not be held responsible for loss of or damage or injury occasioned to any exhibitor or to the property of any exhibitor for any cause what so ever.
9. The exhibitor and exhibits enter entirely at their own risk. In any case of an exhibit, whilst on the showgrounds, causing or being the cause of injury or damage to any other exhibitor or exhibit, OR to the person or property of ANY member of SA ARABS Inc or its officers, the general public, each owner of such exhibit shall indemnify SA ARABS Inc, its officers, officials and members from and against all damages, costs, claims, expenses or liabilities incurred with such incident. The exhibitor shall be liable to SA ARABS Inc its officers, officials and members for any damage or loss occasioned to any of them by the exhibit or exhibitors or agents.
10. SA Arabs Inc has a Risk Management Policy (including Hot weather policy & Child Safe Policy) and all exhibitors are encouraged to read this document available at :-

11. Entry Fees (less \$20 Admin Levy) will only be considered by the Committee for a refund upon production of Veterinary Certificate, verifying that an entered horse is unfit to compete on the day of competition. If a refund is approved by the Committee, that refund will be processed within 30 days. NO REFUNDS WILL BE PROCESSED AT THE SHOW UNDER ANY CIRCUMSTANCES.
12. All entries are final and any requested changes by an Exhibitor to entered classes or class substitutions, after the close of entries, will need to be in WRITING to the show secretary for consideration by the Committee. Any request is at the discretion of the Committee and may not be accepted.
13. A full photocopy of the REGISTRATION CERTIFICATE (including both sides), must accompany the Entry Form and Fees.
14. A horse that in the opinion of the judge/steward or committee has been subject to abuse, is overly stressed or shows whip marks may be excused from the ring.
15. PROTESTS: The following persons may lodge a protest - Competitors or Exhibitors in the disputed Class or any Show Official. The protest must be lodged within ONE HOUR of the completion of the event or class. Protests must be accompanied by \$25.00 cash, refundable if the protest is upheld.
16. DISPUTES COMMITTEE: The Disputes Committee will be made up of the following:
  - i. One Committee Member.
  - ii. The Show Manager and/or Ring Master.
  - iii. One Competitor.
  - iv. No member of this Committee may hear a protest in a Section of the Show in which he/she is exhibiting or competing. The Judge of the Section concerned may be consulted. The decision of the Committee is final and binding.
17. Exhibitors will not be allowed to enter the ring once judging has commenced.
18. Only one Handler/Rider permitted per class, with the exception of Supreme Champion classes.

19. A NEWCOMER Hack is one that has not been shown under saddle as a hack, prior to the 1st of January in its first year of being shown. Once shown under saddle, such horse ceases to be a Newcomer on the 31st of December that same year. All horses in Newcomer classes shall be shown in a snaffle bit.
20. STIRRING: Exhibits are not to be excessively stirred-up. Horses must remain calmly in the marshalling area with a maximum of one handler/rider and one groom until they enter the ring at a walk or a trot. No devices, artificial gadgets or loud noises shall be used to excite waiting horses. Handlers are not to incite stallions to challenge by facing them up to each other or crowding them. The facing up of stallions is strictly prohibited. WHIP ABUSE OF ANY KIND WILL NOT BE TOLERATED.
21. The age of Junior competitors will be calculated from the first day of the show. A copy of a Birth Certificate may be requested.
22. As from the 1st July 2014 all owners of Registered Arabians both Purebred and Derivatives are required to be financial members of the Arabian Horse Society of Australia Ltd.

## **INSURANCE**

A Release and Waiver of Liability Form must be completed by EVERY handler/rider/groom.

Every participant must either be an AHSA Member or an AHSA Affiliate Member. AHSA Members will be covered for Personal Accident Insurance at approved AHSA and AHSA Affiliate events as well as Public Liability Insurance.

If you are not a member of AHSA or SA Arabs or an AHSA affiliate, Insurance coverage can be obtained by becoming a member of SA Arabs. Membership can be done on line at <https://www.trybooking.com/book/event?embed&eid=249384>

A new Participation Membership category within the AHSA's Direct Membership is now available for handlers, riders, strappers etc. to participate. This membership is for Insurance purposes only. A Participant Member cannot conduct any other transactions processed with the AHSA, cannot register, transfer or lease any registered Arabian or Arabian Derivative and cannot be a Panel Judge. Participant Membership will cost \$30.00 and the Participant Member will be covered for Personal Accident Insurance at approved AHSA and AHSA Affiliate events as well as Public Liability Insurance.
